STEWARDSHIP

TAX DEDUCTIBILITY AND PRIORITY POINTS

- *Tax deductibility and point election will be used for the entirety of this pledge unless otherwise noted.*
- *Due to United States IRS regulations, priority points are not eligible to be received for gifts made through a DAF, Community Fund, or Family Foundation since they are inherently 100% tax-deductible.*
- *Priority points accrued are based on donations received and will not be granted should the pledge be left unfulfilled.*

RED POINTS

Donations that accrue Red Points are 0% deductible because they directly and/or indirectly result in the right to purchase seats in an Ole Miss venue. The Red Points total will be used for ranking seat selections and purchases in Ole Miss venues.

BLUE POINTS

Donations that accrue only Blue Points are up to 90% deductible. These priority points have a tangible value to donors, and we have determined that value to equate to 10% of the gift. The Blue Points total will be used for ranking on-campus parking locations and ticket allocations in seating venues NOT on the Ole Miss campus (away game tickets and post season competitions).

**Vaught Society gifts that accrue points will by default accrue all Blue Points (and be 90% deductible). However, deductibility and/or points may be customized up, down, Red or Blue based on preference.*
